Tournament will include 8-10 International teams. This year the Girls week-end includes 7 NCAA women's teams.


This should be an exciting 2 week-end period for soccer in Alabama. Bill Walker will be assigning both events. We will also host Referee Academies

#### Changes to the Registration Process



United States Soccer Federation is in the process of changing the overall registration system. You will no longer be able to go into the old site and register or update your registration. From March 1 forward, you must access the following site for registration:

http:// ussoccer.force.com/ referee/

The full set of instructions

for accessing the site and setting up your account will be on our website, alasoccerref.com. The most important item you must be prepared for is that every referee must have their OWN email address. The email address is your user name so you have to have your own individual account.

If you have already completed your 2015 registra-

tion, you need to do nothing until the next registration year. However, if you have not registered yet, you will need to use the new site for your registration.

### Recertifying Referees

We have had an extreme dip in our registrations this year. Our numbers are down by about 33%. This means that we will not be able to meet our contractual obligations for the remainder of the refereeing year.

We need each of you to con-

Additionally, if you know why they have decided not to return, please let a member of the SRC know so that we can work on making the experience more positive for them so we can have a better retention rate in the next few years.

# Fitness Test — January 2015

The physical fitness test given to all grade 6, some grade 7 and a few grade 8 referees was a great success. It was a 40-meter sprint six times and the interval run of 150 meters followed by walking 50 meters for 10 laps. We had a 98% passing rate.

Make sure you pay attention to the new assessment requirements presented in the 2015 recertification to ensure you are ready for future upgrade opportunities.
